Featured Agency Waco Fire Department

The Waco Fire Department (WFD), the largest paid fire department in McLennan County, was established on April 3, 1873 as a result of a devastating fire that destroyed a number of downtown businesses on March 23, 1873. This led to the formation of Waco's first fire brigade, Waco Hook and Ladder #1. Since then the department has grown to 203 civil service and 5 civilian staff members dedicated to providing the highest level of service to the community in a professional, efficient, and effective manner.

WFD has 13 fire stations, strategically located, covering over 100 square miles to provide prompt and efficient emergency response to a population of over 136,000 citizens and responds to over 18,000 calls for service annually. In October of this year, WFD received official recognition as an ISO Class I fire department, a distinction that only 1% of fire departments in the country have obtained.

The department is divided into four major divisions: Administration, Training, Prevention also known as Community Risk Reduction, and Operations. Emergency Administration responsible for fiscal and administrative responsibilities including budget, human resources, payroll, revenue, asset management. purchasing, and dispatch services. Training is responsible for the initial training of new firefighters, continuing education, health and wellness programs, uniforms and supplies.

Prevention is responsible for fire investigations, arson investigations, community risk reduction activities, commercial building inspections, building plans review, fire safety education, and professional standards.

Emergency Operations, which employs the vast majority of the department's personnel, is responsible for daily emergency response activities, as well as specialized responses such as aircraft rescue firefighting (ARFF), hazardous materials (Hazmat), technical rescue, and swift water rescue and dive team. The Waco-McLennan County Office of Emergency Management also falls under the Fire Department.

The members of the Waco Fire Department continue to set new standards of service, safety, and professionalism as they stand at the ready to protect those who are in danger.

Our Club's History- Part 2

With some of the groundwork laid, Waco Police Chief Brent Stroman met with his Executive Staff in 2010 and began discussions on establishing a 100 Club for Waco Police Officers. Those discussions led to a realization that for proper funding, coverage, and sustainability, the effort would need to expand and include a wider range of law enforcement. Chief Stroman then met with McLennan County Sheriff Larry Lynch, and they discussed including law enforcement within McLennan County. Those meetings throughout 2010 and 2011 led to discussions with McLennan County Police Chiefs at their regular meetings and with then Public Safety Chief Yost Zakhary of Woodway and Police Chief Dennis Stapleton of Lacy Lakeview. It was an initial meeting of these 3 Chiefs and the Sheriff at the Woodway Public Safety Building in 2011, which crafted the beginning of our Club and shaped a vision for a 100 Club for McLennan County law enforcement.
